Item 1. <u>Security and Issuer.</u>

This statement relates to the common stock, \$.001 par value (the "Common Stock") of Sport Endurance Inc. (the "Issuer") having its principal executive office at 1890 South 3850 West, Salt Lake City, UT 84104.

Item 2. <u>Identity and Background.</u>

This statement is being filed by:

- (a) BK Consulting Inc.
- (b) Ralph Montrone who is the Director of BK Consulting Inc located at 1844 South 3850 West, Salt Lake City, UT 84120. Ralph Montrone is also the President of Western Sheet Metal Inc. located at 3919 West 1820 South, Salt Lake City, UT 84104

The persons named in this Item 2 are referred to individually herein as a "Reporting Person" and collectively as the "Reporting Persons." The Reporting Persons have entered into a Joint Filing Agreement, dated as of the date hereof, a copy of which is filed with this Schedule 13D as Exhibit 1 (which is incorporated herein by reference), pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k) under the Act.

(c) The address of the principal business office of the Reporting Persons is 1844 South 3850 West # B, Salt Lake City, UT 84104.

The principal business of BK Consulting Inc. is specializing in IPO consulting, facilitating and filings, underwriting and legal services allowing companies whether new start-up or established our valuable skills and expertise with an interest in pursuing the public arena.

- (d,e) During the five years prior to the date hereof, none of the Reporting Persons has been convicted in a criminal proceeding or has been a party to a civil proceeding ending in a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.
 - (f) BK Consulting Inc is organized under the laws of the State of Nevada and Ralph Montrone is a United States citizen.

Item 3. Source and Amount of Funds or Other Consideration.

On June 3, 2013, the Issuer amended its outstanding promissory notes held by the Reporting Persons. These amended promissory notes are no longer interest bearing notes, and are now immediately convertible to common stock (see Exhibit 2). The Convertible note was exercised on November 8, 2013 at a price per share of \$.002 (see Exhibit 3).

Item 4. <u>Purpose of Transaction.</u>

The Reporting Persons acquired the Sport Endurance Inc. Shares for investment purposes. Depending on market conditions, its continuing evaluation of the business and prospects of the Issuer and other factors, BK Consulting Inc. and other Reporting Persons may dispose of or acquire additional shares of the Issuer.

None of the Reporting Persons have any present plans or proposals that relate to or would result in any change in the business, policies, management, structure or capitalization of the Issuer. The Reporting Persons reserve the right to acquire, or dispose of, additional securities of the Issuer in the ordinary course of their business, to the extent deemed advisable in light of their general investment and trading policies, market conditions or other factors. The Reporting Persons may engage in discussions from time to time with other stockholders of the Issuer regarding the acquisition by the Reporting Persons or others of shares of the Issuer's Common Stock held by such stockholders.

The Reporting Persons may seek information from management and the Issuer's Board of Directors, and may engage in further discussions with management, the Issuer's Board of Directors, other stockholders of the Issuer and other relevant parties, concerning the business, operations, governance, management, strategy, capitalization and/or future plans of the Issuer, or in proposing one or more of the other actions described in subparagraphs (a) through (j) of this Item 4.

Except as set forth above, none of the Reporting Persons has any present plans which relate to or would result in:

- (a) The acquisition by any person of additional securities of the Issuer, or the disposition of securities of the Issuer;
- (b) An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Issuer or any of its subsidiaries;
- (c) A sale or transfer of a material amount of assets of the Issuer or any of its subsidiaries;
- (d) Any change in the present Board of Directors or management of the Issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- (e) Any material change in the present capitalization or dividend policy of the Issuer;
- (f) Any other material change in the Issuer's business or corporate structure;
- (g) Changes in the Issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the Issuer by any person;
- (h) Causing a class of securities of the Issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
- (i) A class of equity securities of the Issuer becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Act; or
- (j) Any action similar to any of those enumerated above.

Item 5. <u>Interest in Securities of the Issuer.</u>

(a) BK Consulting Inc. is the record owner of the Sport Endurance Inc. Shares. As the director of BK Consulting Inc, Ralph Montrone may be deemed to own beneficially the Sport Endurance Inc Shares.

Each Reporting Person disclaims beneficial ownership of the Sport Endurance Inc. Shares other than those shares which such person owns of record.

The percentage of outstanding Common Stock of the Issuer which may be deemed to be beneficially owned by each Reporting Person is set forth on Line 13 of such Reporting Person's cover sheet. Such percentage was calculated based on the 31,358,903 shares of Common Stock reported to be outstanding.

- (b) Regarding the number of shares as to which such person has:
 - (i) sole power to vote or to direct the vote: See line 7 of cover sheets
 - (ii) shared power to vote or to direct the vote: See line 8 of cover sheets
 - (iii) sole power to dispose or to direct the disposition: See line 9 of cover sheets.
 - (iv) shared power to dispose or to direct the disposition: See line 10 of cover sheets

- (c) Except as set forth in Item 3 above, none of the Reporting Persons has effected any transaction in the Common Stock during the last 60 days.
- (d) No other person is known to have the right to receive or the power to direct the receipt of dividends from, or any proceeds from the sale of, securities beneficially owned by any of the Reporting Persons.
- (e) Not applicable.

Item 6. Contracts, Arrangements, Undertakings or Relationships with Respect to Securities of the Issuer

As reported in the Company's Form 10Q filed July 15, 2013, for the period ending May 31, 2013, the Company had entered into multiple Promissory Note agreements with BK Consulting Inc. On June 3, 2013 the Company amended its Promissory Note agreements to no longer be interest bearing notes and is immediately convertible to common stock (Exhibit 2).

PROMISSORY NOTE AMENDMENT

This Promissory Note Amendment (the "Amendment") is entered into effective as of as of June 3, 2013 by and between BK Consulting Inc. (<u>Investor/Note-holder</u>") and Sport Endurance, Inc., a Nevada corporation (the "<u>Company</u>"), with reference to the following facts:

WHEREAS, Investor/ Note-Holder has loaned certain funds to the Company as described in multiple Promissory Note -Agreements dated before May 31, 2013 (the "Note Agreements"), as extended on June 3, 2013, of which the Company approved an Amendment whereby all outstanding Promissory Notes shall no longer bear 8 % interest after May 31, 2013 and the thus said Promissory Notes are immediately convertible to Common Stock at a price of \$.002 per share at the Investor/Note Holder's discretion.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Investor/Note-Holder and the Company agree as follows:

- 1. Promissory Notes no longer bear 8 % interest Effective as of June 3, 2013, Outstanding Promissory Notes which include principle and interest total \$30,033.00 will no longer bear 8 % interest after May 31, 2013.
- 2. <u>Promissory Notes are Immediately Convertible to Common Stock.</u> Promissory Notes are immediately convertible into shares of Common Stock at Investor/Note Holder's discretion at a price per share of \$.002. Upon execution of a Convertible Note Agreement, the Company shall instruct its transfer agent to issue shares of Common Stock to the Investor/Note-Holder.

WHEREAS, Investor/ Note-Holder has loaned certain funds to the Company as described in multiple Loan Agreements dated before May 31, 2013 (the <u>Loan Agreements</u>"), as extended on June 3, 2013 (the <u>Promissory Note Amendment</u>" or the "<u>Promissory Note</u>"), of which the Company approved that all outstanding debt is now convertible to Common Stock at a price of <u>\$.002</u> per share. Investor/ Note-Holder desires to exercise its option to convert the Promissory Note into shares of Common Stock.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Investor/Note-Holder and the Company agree as follows:
